- Evaluation and recommendation (and potentially development either solely or jointly) of educational programs to be provided to physicians
- Review of impact on Pre-certification – working directly with payors and third party vendors that perform pre-certifications to evaluate the readiness of payors to determine potential direct impact to the billing process.
