Woodward has authored or co-authored 17 books, all of which have been national non-fiction best sellers. His most recent book, The Price of Politics (September, 2012), is based on 18 months of reporting and is an intimate, documented examination of how President Obama and the highest profile Republican and Democratic leaders in the United States Congress attempted to restore the American economy and improve the federal government's fiscal condition. Drawn from memos, contemporaneous meeting notes, emails and indepth interviews with the central players, the book addresses the key issue of the presidential and congressional campaigns, the condition of the American economy and how and why we got here. Providing verbatim, day-by-day, even hourby-hour accounts, the book shows what really happened, what drove the debates, negotiations and struggles that define and will continue to define the American future.

#### GENERAL SESSION 3:30 - 5:00 pm ACOs - What's All the Fuss and What Should I Be Doing About It!?

#### Steve Verno

This presentation will cover the basics of what constitutes an Accountable Care Organization (ACO). Understanding the difference between current medical care and the ACO concept is critical - ACO patient responsibilities when obtaining care from a network or out of network ACO. The basics of the new Patient Centered Medical Home, which is outlined in the Patient Protection and Accountability Care Act (PPACA) will also be clearly stated.

#### **Objectives:**

- Answer the question about whether claims will still be used to pay physicians
- Provide answers to the importance of insurance to ACO to provider payment budgeting
- Offer information regarding using the ACO to help reduce fraud, waste, abuse and duplicate services.
- Answer the question whether the medical billing profession will still exist or become extinct.
- Show the importance of the medical billing profession and medical billing management under the ACO concept of medical care
- Provide information regarding the importance of a strong and thorough contract between an ACO and insurance company and ACO and physician.
- Provide insight as to how the ACO and provider will be paid for services rendered.
- Answer the question whether the ACO is a death sentence for an patient who is extremely ill such as a patient with cancer.

GENERAL SESSION 8:00 - 9:30 am A Focus on ICD-10 End-to-End Testing Readiness from a Collaborative Perspective: Panel Discussion

Focus will be on ICD-10, not from a *technical* perspective, but from a *collaboration* perspective. As we move into the upcoming compressed waves of compliance, it is critical that we define, as an industry, the processes and procedures, as well as 'sharing' information that can be used and reused as each mandate hits.

#### CONCURRENT EDUCATIONAL SESSIONS 10:30 - Noon A. Laptops, Portables and HIPAA Breaches

#### Jim Sheldon-Dean

The adoption of new, portable information technologies is revolutionizing the provision and documentation of health care in America. Every day, both patients and staff discover new ways to use laptops, smart phones, and tablets in health care, and healthcare IT departments are struggling to keep up with the security needs of these devices. One of the unfortunate results of such widespread adoption of portable technologies is that without the adoption of good security practices, including risk analysis and mitigation, they can become the source of HIPAA privacy and security breaches. Data at rest on devices such as laptops and other portable technologies increasingly must be encrypted to reduce the risks of breaches and their significant costs and impacts of notification.

The HIPAA Breach Notification Rule requires all HIPAA covered entities and business associates to follow a number of steps to be in compliance in the event of a breach of the privacy and security of protected health information that risks causing financial, reputational, or other harm to an individual. For every potential breach of PHI, the entity must evaluate the incident and take action to notify affected individuals and the US Department of Health and Human Services if there is a risk of harm. Entities must adopt a breach notification policy and procedures to ensure accurate reporting and documentation of breaches, and must follow the standards and specifications of the HIPAA Security Rule to protect information from breaches by using encryption and proper disposal methods meeting Federal standards, particularly when it comes to laptops and portable devices.

#### **Objectives:**

• Appreciate the risks inherent in using portable devices and technologies, the most frequent reasons for breaches involving them and how can they be prevented.

- Comparison of typical policy, documentation, and training considerations for laptops and portable devices, and their security.
- Understand the background and requirements of the Breach Notification Rule and what goes into an effective breach notification policy.
- Adopt policies, train then, document their application, and conduct drills in breach response, particularly for laptops and portable devices.

#### B. RACs, Go Ahead, Do You Feel Lucky?

The joke goes that if I knew the difference between anecdote and antidote, my friend would still be alive. How often have we heard someone say something like "we've been doing it that way for 20 years..."?
