Complete a Claim Status Inquiry transaction on NaviNet.

If we've requested additional information from you (the provider), you'll see an "Attach" link.** It's in the upper right corner — simply click it to attach your documentation.

We strongly recommend including an electronic copy of the Explanation of Benefits (EOB)/Explanation of Provider Payment (EPP) of the pended claim as one of your documents. The remarks have a code we use to route your documentation to the correct area for handling.

Click the "Attach" button. NaviNet will forward your documentation to us for review.

Tips

- You can attach as many documents as you'd like. Each document must be less than 16 MB.
- Here are the file types we can accept:
 - Microsoft[®] Word (.doc, .docx)
 - Microsoft[®] Excel (.xls, .xlsx)
 - Adobe[®] PDF (.pdf)
 - Images (.gif, .jpg, .jpeg, .png, .tif)
 - Text (.rtf)
- Make sure your files aren't password protected.
- NaviNet is available to all providers, whether you're contracted or not.

 - Log in to NaviNet at connect.navinet.net.

Please give us a reasonable amount of time to review your documentation and claim. Don't see an updated status after 30 to 45 days? Just complete a new electronic Claim Status Inquiry on that claim.
